***Captain (Ret,d) J H Youles, former Regimental Secretary, the last to hold the appointment for the Essex and Royal Anglian Regiments Association, was honoured with the presentation of the Lord Lieutenants recognition by The Lord Petre, Her Majesties Lord Lieutenant for Essex at an Officers Dinner held at Chelmsford Army Reserves Centre in 18th April 2013.***

***Her Majesties Lord Lieutenants award is the highest award to be bestowed before national honours, awarded where the recipient has connection with Her Majesties Armed Forces. Long service alone does not constitute the main criteria for the award; it is services rendered of an exceptionally high order, actions of which set the recipient apart from others.***

***His nomination with supporting testimonials was considered by an Honours Board with final approval granted by Her Majesties Lord Lieutenant. The award being made for services to the Country, Community and the Nation as a whole. His citation stating for services to the Armed Forces and Veterans in the County of Essex.***

***Captain Youles has a long connection with the armed forces having served in the 4/5<sup>th</sup> Battalion the Essex Regiment and administrative roles serving in two county ACF,s, affiliated to the Royal Anglian Regiment. He also served in a Home Office police force and with the Ministry of Defence Police, a special branch in which he specialised.***

***He served as Chairman of the 4<sup>th</sup> Essex Association and board of trustees until its cessation following which he was to oversee formation its successor, the 4/5 Essex Branch until cessation of the antecedent regimental association when it was re-titled Chelmsford branch of the Royal Anglian Regiment Association of which he was appointed interim chairman.***

***Additional to other appointments he was appointed Regimental Secretary, the Essex Regiment Association to oversee all aspects of management including its branches and the management of its merger into the Royal Anglian Regiment Association. He was also a member of the Essex County (Military) Committee, Royal Anglian, and committee of the Regimental Chapel.***

***He was responsible for organising reunions, services, dedications, regimental visits, funerals, award ceremonies, welfare, maintaining contact with regimental and linked organisations, military and civil and represented the regiment at functions, dedications, freedom parades and special events including Buckingham Palace for the centenary of the Territorial Army.***

***Other awards include "Honorary Vice President" 4<sup>th</sup> Battalion The Essex Regiment Association - Colonel of the Royal Anglian Regiments certificate, in recognition of much valued services to the regiment – Honorary Vice President Chelmsford Branch Royal Anglian Regiment Association and a special certificate recognising his time as Regimental secretary.***

***His non military services within the County of Essex included service as a school governor, support to the Royal National Lifeboat Institution, a co-opted board member of a former servicemen's club and St John Ambulance in which he was appointed a Divisional President of St John. Also attending seminars relating to crime and advisory.***

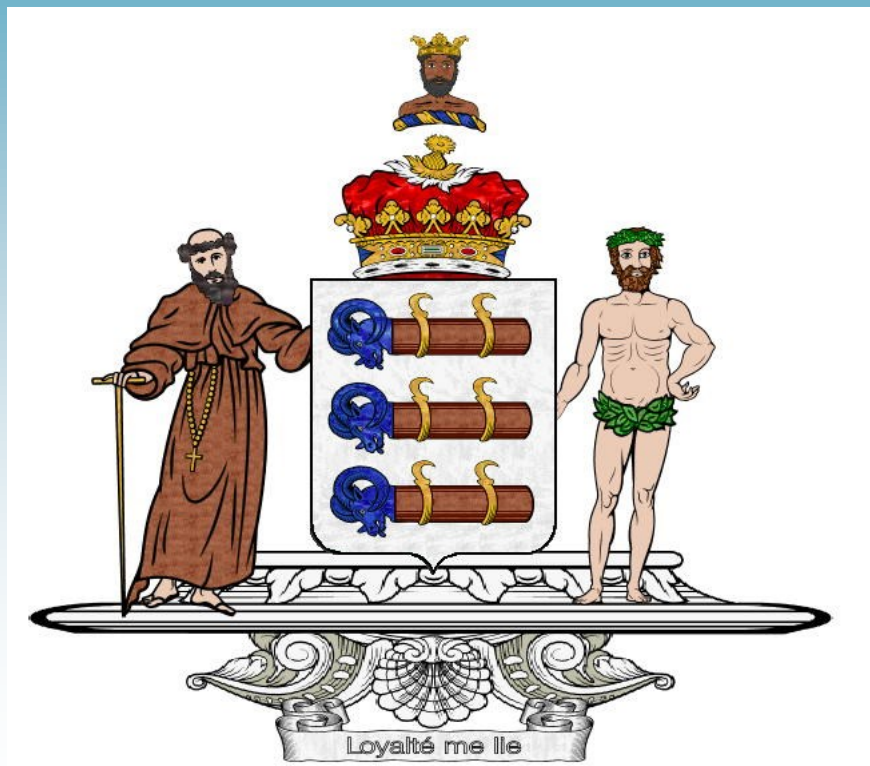
